**MOTION Carried,** by Talaski second by Tait to approve the Caseville Chamber of Commerce's request for the 1st Annual Caseville Cruise Night on June 3, 2023. **5-0 Approved.** 

**RESOLUTION #2023-12,** ROLL CALL, by Rathje second by Tait to approve the submission of a Congressional Direct Spending grant request in the amount of \$556,000 (\$695,000 Project Total) for improvements to the Caseville Water System. **ROLL CALL VOTE Approved 5-0.**

Louis Johnson asked about the County Beach exits. Talaski said both ends will be two-way traffic.

#### **COUNCIL COMMENTS:**
